THE KIA TŪTAHI STANDING TOGETHER RELATIONSHIP ACCORD

<u>The Kia Tūtahi Standing Together Relationship Accord</u> is an important symbol of commitment between the communities of Aotearoa New Zealand and the Government of New Zealand to build strong relationships.

The Prime Minister and the Minister for the Community and Voluntary Sector signed the Accord at a ceremony at Parliament on 1 August 2011. Forty representatives from the communities of Aotearoa New Zealand and government agencies in Wellington attended the ceremony. At the ceremony, 29 people from communities signed the Accord and 11 officials endorsed it.

Department of Labour (Employment Relations) - preparing your workplace for an emergency

A resource developed by the Department of Labour can help prepare your workplace for an emergency. All workplaces are required to have procedures in place to effectively manage emergencies that could happen at work. A planned emergency response is required under health and safety legislation to protect all people present in the event of a fire, natural disasters including earthquake, chemical spills, LPG leaks and as well as in the event of someone needing CPR and First Aid. Employers have a legal responsibility to have plans in place in the event of any emergency. To help develop effective emergency response plans for your business visit the Department of Labour emergency procedures webpage. The Ministry of Civil Defence and Emergency Management also has information for how to prepare for an emergency.

A specific lesson learned from the earthquakes in Canterbury has been the importance of keeping electronic and hardcopy backup files of essential business information. Workplaces became

inaccessible and business owners who did not have staff contact details were unable to check their immediate safety and wellbeing. In many cases businesses were unable to resume normal work because essential data was lost.

Ministry of Social Development

<u>Fresh Start Reforms in Operation</u> is a progress report on the implementation of the Fresh Start youth justice reforms, which includes current trends in youth offending. The Fresh Start reforms, introduced in October 2010, are the most fundamental change to the youth justice system in the last 20 years. Youth Court judges now have more options to deal with offenders, including powers to order mentoring programmes, alcohol and drug rehabilitation, and parenting education, and the ability to impose longer sentences for our most serious offenders. The report shows there has been good progress on rolling out the new programmes and initiatives, and while it's too early to make judgements on the effectiveness of the reforms, information gathered so far shows promise. The report also highlights the work currently underway to support the improvement of the youth justice and child offender systems. This includes ensuring there are strong monitoring systems in place to measure the effectiveness of interventions, and help inform future development of, and improvements to, programmes and initiatives. Charities Commission

Read the <u>latest news</u> from the Charities Commission. The July newsletter includes advice on how to access data from the Charities register.

Until now, people wanting information from the Charities Register have only been able to use the current "simple search", which allows you to find a list of individual charities. If you wanted "aggregated" financial or other information about (say) charities that operate in the Auckland region, and who help young people, you would have had to look at each charity's summary page and financial information separately, and then add it all together yourself. This is no longer the case! With the Advanced Search and/or Open Data, you can now delve into the wealth of information held on the Charities Register for yourself, and find out what you want to know about how charities affect New Zealand's economy, people, and culture. And the great thing is that the data is updated daily — as new charities and their information or added or updated, or charities wind up and leave the Register, their data is updated.

Families Commission

The 50 Key Thinkers Forum, hosted by the Families Commission in Wellington on 11 May 2011, was conceived as a starting point to ignite and reframe thinking about family and whānau support. A summary of key releases and speeches is below:

Hon Tony Ryall

New Members of the National Health Committee (12 August). Health Minister Tony Ryall has announced five new members of the National Health Committee. The new members of the Committee are Craig Climo, the Chief Executive Officer of Waikato DHB, Ross Laidlaw, a retired lawyer and businessman from Wanaka, Sharon Mariu, a businesswoman and member of the Waikato DHB, Dr Mark O'Carroll, a respiratory physician from Auckland, Alex Price, the Chief Executive of Fertility Associates. They join Auckland paediatric surgeon Mrs Anne Kolbe, who was appointed as Chair in April. The committee advises the Minister of Health on health and disability issues, and is involved in the assessment of new diagnostic and treatment services.

Reduction in the number of government agencies (11 August). The Government has announced final decisions on changes that will further reduce the number of government agencies. The decisions are to:

- create an arm's-length health promotion agency that will take over the functions of the Alcohol Advisory Council of New Zealand (ALAC), the Health Sponsorship Council (HSC) and relevant functions of the Ministry of Health.
- bring forward the disestablishment of the Mental Health Commission and transfer functions to the
 Office of the Health and Disability Commissioner (HDC) and establish a new Mental Health
 Commissioner within the HDC.
- disestablish the Crown Health Financing Agency, and transfer some of its functions to the Ministry of Health, while others continue to be provided by Treasury's Debt Management Office.
- transfer the functions of the Charities Commission to the Department of Internal Affairs, while providing for independent registration and related functions through a statutory board.
- disestablish the Health Act Boards of Appeal, the Maritime Appeal Authority, and the Land Valuation Tribunals, and transfer their functions to the District Court.

Better Help for Smokers to Quit (29 July). Health Minister Tony Ryall has congratulated the Lakes District Health Board for achieving 100 per cent in the 'Better Help for Smokers to Quit' preventive health target, in the last quarter. The national preventive health target is that 90 per cent of hospitalised smokers get advice and support to quit, and Lakes is the first DHB to achieve 100 per cent for a quarter.

Medicines Regulations (12 July). The Medicines Regulations 1984 and the Medicines (Standing Order) Regulations 2002, have been amended to better align the law with modern medical practice.

Diabetes (11 July). Health Minister Tony Ryall has announced a new set of guidelines is available to help health professionals manage patients with type 2 diabetes. The guidelines have been developed by the Ministry of Health and the New Zealand Guidelines Group, and are available at http://www.nzgg.org.nz/practice-tools/diabetes. The web-based tools will be useful for primary care clinicians to help identify patients at high risk of diabetes-related complications, manage raised blood pressure effectively, control blood sugar levels well, and start insulin treatment appropriately.

Hon Tariana Turia

Government to sign Relationship Accord with Communities (2 August). Monday, 1 August, will mark an important milestone in work being progressed to build stronger relationships between communities and government. Prime Minister, John Key, and Minister for the Community and Voluntary Sector, Tariana Turia, will join with a wide variety of community and government representatives, Ministers and MPs in Parliament's Grand Hall to sign and celebrate the Kia Tūtahi Standing Together Relationship Accord.

"The Accord is a significant step in an ongoing journey to improve relationships between communities and government" said Mrs Turia. Mrs Turia says the Accord signals the commitment from both government and communities to work together to achieve positive social, economic and environmental outcomes. By putting the principles of the Accord into practice, better outcomes are expected to result for communities from collaboration across central and local government, community organisations, the private sector and citizens. The Accord was developed by a joint community-government steering group co-chaired by Hori Awa and Don Gray. "We are all awaiting the Signing Ceremony with great excitement" said Mrs Turia. "There will also be further opportunities to sign the accord at regional ceremonies over the next month; or to sign online'.

Whanau Ora - Minister speaks up to confront funding suggestions (3 August). "From time to time, there has been speculation that when a decision has been made to cut a programme, it must be to support Whanau Ora. I've heard it said in the family violence field; wild rumours have circulated around health providers, and now I've heard that Northland provider, has suggested that their youth programme (funded out of the Healthy Eating, Healthy Action fund) was cut and the funding transferred to Whanau Ora. "Truth is, the money that is being used for Whanau Ora was not previously committed to any particular initiative or programme; it was in fact funded by reprioritising existing funding, primarily within Vote Social Development". Communications upgrade for hearing and speech impaired communities (28 July). The Deaf, deaf-blind, speech and hearing-impaired community will soon benefit from an expanded range of communication services, Minister of Information and Communication Technology, Steven Joyce, announced today. New services to be progressively introduced from late this year will include captioned telephony, which allows people to read live captions of spoken phone conversations. People will also be able to contact the relay contact centre by mobile phone, and use a prepaid calling card to make international calls by Internet relay (joint press release by Minister Turia and Minister Joyce)

Smokefree Environments (Controls and Enforcements) Amendment Bill (14 July). For Minister Turia's speech moving that the Smoke-free Environments (Controls and Enforcement) Amendment Bill be read a third time click on speech. The Amendment Bill aims to remove tobacco displays from outlets and also include harsher penalties.

Maori health is every health worker's business (12 July). Minister Turia discusses inequalities and cultural competency - Minister Turia's speech

Good progress in implementing NZ Carers' Strategy (8 July). Associate Minister for Social Development and Employment, Hon Tariana Turia, says good progress is being made to implement the New Zealand Carers' Strategy and Five Year Action Plan and outlines the key achievements. Hon Jonathan Coleman

Canterbury (7 July). Efforts are being stepped up to support quake-stricken Cantabrians with more resources being channelled into mental health services, says Associate Health Minister Dr Jonathan Coleman. Extended GP consultations, increased counselling support and a new specialist earthquake response team has been established to help people cope with the on-going effects of the series of major earthquakes and aftershocks in the region.

The services are being supported through an extra \$1.5 million in funding from the Canterbury District Health Board for primary, secondary and community mental health care services.

New guidelines to improve dementia and addiction services (6 July). Dementia sufferers and older people with mental health and addiction problems will benefit from new guidelines for treatment services says Associate Minister of Health Jonathan Coleman. The <u>national guidelines</u> aim to improve access to services and provide consistency in service delivery across all District Health Boards and aged care providers. The guidelines also focus on workforce development, strengthening clinical leadership and providing services based on need, not age. The launch of the guidelines follows the Budget 2011 announcement which delivers an extra \$44 million in funding over four years for people living with dementia.

Hon Peter Dunne

Bicultural ASIST (11 August). Associate Health Minister Dunne's address celebrates developing the word's first Bicultural ASIST tool and the launch of Lifeline's new SafeTALK suicide prevention education campaign.

Misuse of Drugs Act (9 August). Associate Health Minister Peter Dunne today announced that he has issued the first temporary class drug notice under the Misuse of Drugs Act that was amended last week, and that all Kronic and other synthetic cannabis products will be off the market by next Wednesday. "The first temporary class drug notice is being gazetted today. The seven day period until it takes effect begins today," Mr Dunne said.

REQUESTS FOR SUBMISSIONS

Government Green Paper on Vulnerable Children (submissions close 28 February 2012)

A Government Green Paper has been produced on vulnerable children who have childhoods that make it unlikely they will thrive, belong, and achieve. The Green Paper has some ideas about what the Government could do to improve outcomes for vulnerable children. It aims to open up discussions about the issues and it is a chance for you to have your say. Submissions are due by 28 February 2012. Once all of the submissions have been received and analysed, a White Paper will be released outlining the Vulnerable Children's Action Plan which will be published in 2012. Rules for Incorporated Societies (Submissions close on 30 September 2011)

The Law Commission is an independent Crown entity under the Crown Entities Act 2004. It is funded by government and reviews areas of the law that need updating, reforming or developing. It makes recommendations to Parliament. The Commission is consulting on the legal structure and rules of incorporated societies. Currently much of the not-for-profit sector in New Zealand is governed by the century old Incorporated Societies Act 1908 – an Act which the Law Commission argues is in need of major reform. The Commission is seeking feedback on a range of issues and options for reform raised in the paper "Reforming the Incorporated Societies Act 1908" including:

- whether all societies should, as a condition of incorporation, be subject to certain minimum governance rules that they cannot vary;
- whether a new Act ought to provide a code that makes the obligations of committee members clearer;
- how the Act should provide for the resolution of disputes between members and their societies;
- what rules societies ought to be required to have in their constitution, and the nature of those rules.

The Commission also considers whether a new Incorporated Societies Act should also replace the ability to incorporate under the Charitable Trusts Act. The paper is available here. To make a submission go to Make a submission.

Proposal that Traditional Chinese Medicine Become a Regulated Profession (closes 19 August)

Traditional Chinese medicine (TCM) practitioners groups have applied to the Ministry of Health to be regulated under the Health Practitioners Competence Assurance Act 2003. The proposal to regulate the TCM profession outlines the reasons for regulating a profession, a brief background on the profession and invites comments on the proposal.
